MUNICIPAL ORDINANCE NO. 06, S.2022

AN ORDINANCE AUTHORIZING THE VICE MAYOR TO AUGMENT APPROPRIATION IN ANY ITEM IN PERSONAL SERVICES (PS) AND IN MAINTENANCE AND OTHER OPERATING EXPENSES (MOOE) IN THE APPROVED ANNUAL EXECUTIVE BUDGET OF THE MUNICIPALITY FOR CY 2022, UTILIZING SAVINGS AND OTHER APPROPRIATIONS AVAILABLE, IN THE OFFICE OF THE VICE MAYOR AND SANGGUNIANG BAYAN

WHEREAS, Section 336, Book II of R.A. 7160 otherwise known as the "Local Government Code of 1991" states – Use of Appropriated Funds and Savings. – Funds shall be available exclusively for the specific purpose for which they have been appropriated. No ordinance shall be passed authorizing any transfer for appropriations from one item to another. However, the local chief executive or the presiding officer of the Sanggunian concerned may, by ordinance, be authorized to augment any item from savings in other items within the same expense class of their respective appropriations;

WHEREAS, relative and in observance to the above provision, the Vice Mayor has requested authority to augment appropriations in any items in Personal Services (PS) and in Maintenance and Other Operating Expenses (MOOE) in the approved Annual Executive Budget of the Municipality for CY 2022 in the Office of the Vice Mayor and the Sangguniang Bayan Office, utilizing Savings and other appropriations available provided they are of the same expense class;

WHEREAS, the Sanggunian believes in the wisdom of the Vice Mayor to make the necessary adjustments in appropriations in all offices under the Office of the Vice Mayor and the Sangguniang Bayan Office;

NOW, THEREFORE, on motion of the Hon. Rey G. Canindo, which was duly seconded by Hon. Dennis E. Caraecle, the body;


BE IT enacted by the Sangguniang Bayan in session assembled that:

Section 1. Authority is hereby granted to the Honorable Ryan S. Zerrudo, to augment appropriation in any item in Personal Services (PS) and in Maintenance and Other Operating Expenses (MOOE) in the Approved Annual Executive Budget of the Municipality for C.Y. 2022 utilizing Savings and other appropriations available in the Office of the Vice Mayor and the Sangguniang Bayan Office, pursuant to Section 336 Book II of R.A. 7160;


Section 2. The purpose of Fund Augmentation is for the necessary adjustments in the appropriations;

Section 3. This Appropriation Ordinance shall take effect upon approval until the end of the Calendar Year 2022.
