**RESOLUTION NO.113 S.2022**

**A RESOLUTION RECOMMENDING THE CONVERSION OF THE MUNICIPAL ROAD INTO NATIONAL ROAD DECLARED AS A MISSING LINK, THE 197-METER GAP BETWEEN TWO (2) SECONDARY ROADS WITHIN THE MUNICIPALITY OF SARA, ILOILO.**

**WHEREAS**, the Sangguniang Bayan of Sara, Iloilo is a constituted Legislative Body organized by law to pass, enact, and adopt ordinances, resolutions and other legislative measures for the effective administration in relation with the affairs of the Municipality;

**WHEREAS**, pursuant to the Local Government Code of 1991 or the Republic Act of 7160 in Section 17, Basic Services and Facilities – (a) Local government units shall endeavor to be self-reliant and shall continue exercising the powers and discharging the duties and functions currently vested upon them. They shall also discharge the functions and responsibilities of national agencies and offices devolved to them pursuant to this Code. Local government units shall likewise exercise such other powers and discharge such other functions and responsibilities as are necessary, appropriate, or incidental to efficient and effective provisions of the basic services and facilities enumerated herein;

**WHEREAS**, the proposed conversion will connect the 197-meter gap between the two secondary national roads, the Iloilo East-Coast Capiz Road and Passi-San Rafael-Lemery-Sara Road;

**WHEREAS**, such conversion in effect will include the 197-meter gap in the national road development program/s of the national government under the General Appropriations Act and Department of Public Works and Highways;

**NOW THEREFORE**, on motion by Hon. Rey G. Canindo and duly seconded by Hon. Neptali c. Salcedo, Jr., the body;

**RESOLVED**, as it is hereby resolved authorizing the conversion of the municipal road into national road declared as a missing link, the 197-meter gap between the two (2) secondary roads within the Municipality of Sara, Iloilo.


