**RESOLUTION NO. 111 S.2022**

**A RESOLUTION AUTHORIZING THE MUNICIPAL MAYOR TO ALLOW THE USE OF THE MUNICIPAL-OWNED LOT AT BARANGAY ANORING, SARA FOR THE CONSTRUCTION OF THE BARANGAY MULTI-PURPOSE HALL OF BARANGAY ANORING, SARA, ILOILO.**

**WHEREAS**, the Sangguniang Bayan of Sara, Iloilo is a duly constituted Legislative Body organized by law to pass, enact, and adopt ordinances, resolutions, and other legislative measures for the effective administration in relation with the affairs of the Municipality;

**WHEREAS**, pursuant to Local Government Code of 1991, in Section 17 Basic Services and Facilities- (a) Local government units shall endeavor to be self-reliant and shall continue exercising the powers and discharging the duties and functions currently vested upon them. They shall also discharge the functions and responsibilities of national agencies and offices devolved to them pursuant to this Code. Local government units shall likewise exercise such other powers and discharge such other functions and responsibilities as are necessary, appropriate, or incidental to efficient and effective provisions of the basic service and facilities enumerated herein:

(b)(1) For a Barangay: (vi) Infrastructure facilities such as multi-purpose hall, multi-purpose pavement, plaza, sports center, and other similar facilities;

**WHEREAS**, Barangay Anoring has requested financial assistance from the National Government to fund the construction of its Barangay Hall and its Sangguniang Barangay has submitted before the august body a Barangay Resolution No. 012, Series of 2022 requesting to allow the use of the land owned by the Municipality of Sara, for the construction of barangay multi-purpose hall, considering that the old hall was already dilapidated;

**WHEREAS**, the land recommended by the said Sangguniang Barangay to be used for the construction of the Barangay Multi-Purpose Hall is located at Barangay Anoring and has the following details: Tax Declaration No. 39-0007-00479 and Lot no. 6, Block no. 6 with an area of 0.3695 hectare.

**NOW THEREFORE**, on motion by Hon. Rey G. Canindo and duly seconded by Hon. Delson T. Sonza, Jr., the Body:


