**RESOLUTION NO. 110 S.2022**

**A RESOLUTION AUTHORIZING THE MUNICIPAL MAYOR TO ALLOW THE USE OF THE MUNICIPAL-OWNED LOT LOCATED AT BARANGAY ANORING, SARA FOR THE CONSTRUCTION OF THE BARANGAY HEALTH CENTER OF BARANGAY ANORING, SARA, ILOILO.**

**WHEREAS**, the Sangguniang Bayan of Sara, Iloilo is a duly constituted Legislative Body organized by law to pass, enact, and adopt ordinances, resolutions, and other legislative measures for the effective administration in relation with the affairs of the Municipality;

**WHEREAS**, pursuant to the Local Government Code of 1991, in Section 17- Basic Services and Facilities, (a) Local government units shall endeavor to be self-reliant and shall continue exercising the powers and discharging the duties and functions currently vested upon them. They shall also discharge the functions and responsibilities of national agencies and offices devolved to them pursuant to this Code. Local government units shall likewise exercise such other powers and discharge such other functions and responsibilities as are necessary, appropriate, or incidental to efficient and effective provisions of the basic service and facilities enumerated herein:

b. (1) For a Barangay: (i) Health and social welfare services which include maintenance of barangay health center and day-care center; and, (iii) Services and facilities related to general hygiene and sanitation, beautification, and solid waste collection;

**WHEREAS**, the Barangay Anoring is a recipient of the KALAHI-CIDSS-funded program and its Sangguniang Barangay deemed it necessary to construct and establish a health center to be utilized by its health personnel and to be used as a disaster-response forward facility of the municipal government;

**WHEREAS**, the Sangguniang Barangay of Barangay Anoring submitted to the august body a Barangay Resolution No. 011 Series of 2022, requesting the municipality to grant the barangay a permission to build the aforementioned health center on the land owned by the Municipality of Sara;

**WHEREAS**, the land recommended by the Sangguniang Barangay to be used for the construction of the aforementioned health center is located at Barangay Anoring and has the following details: Tax Declaration No. 39-0007-00479 and Lot no. 6, Block no. 6, with an area of 0.3695 hectare.


**NOW THEREFORE**, on motion by Hon. Rey G. Canindo and duly seconded by Hon. Delson T. Sonza, Jr., the Body:
