RESOLUTION NO. 108 S.2022

A RESOLUTION AUTHORIZING THE LOCAL CHIEF EXECUTIVE, HON. JON N. AYING, IN BEHALF OF THE MUNICIPALITY OF SARA TO ENTER AND SIGN THE MEMORANDUM OF AGREEMENT (MOA) FOR THE ESTABLISHMENT OF THE MULTI-PURPOSE COUNSELLING AND FAMILY DEVELOPMENT CENTER WITH PROVINCIAL GOVERNMENT OF ILOILO REPRESENTED BY THE PROVINCIAL GOVERNOR OF ILOILO, HON. ARTHUR R. DEFENSOR JR.

WHEREAS, the Sangguniang Bayan of Sara, Iloilo is a duly constituted Legislative Body organized by law to pass, enact, and adopt ordinances, resolutions and other legislative measures for the effective administration of the proceedings in relations with the affairs of the municipality;

WHEREAS, Presidential Decree No. 965 issued on July 20, 1978 requires all applicants for marriage license to receive instructions about responsible parenthood and family planning;

WHEREAS, pursuant to Philippine Population Management Program (PPMP), the Province of Iloilo deemed it necessary to establish a Multi-Purpose Counselling and Family Development Center in order to conduct Pre-Marriage Counselling sessions and the Municipality of Sara is one of the municipalities chosen for the establishment of the said center;

WHEREAS, the Municipality of Sara is beyond grateful for the opportunity to have Multi-Purpose Counselling and Family Development Center;


