A RESOLUTION AUTHORIZING THE MUNICIPAL MAYOR TO ENTER INTO AND SIGN THE MEMORANDUM OF AGREEMENT (MOA) WITH “DAAN SA KAUNLARAN TECHNICAL AND TRAINING INSTITUTE, INC.” FOR THE IMPLEMENTATION OF TECHNICAL VOCATIONAL EDUCATION PROGRAM FOR THE MUNICIPALITY OF SARA.

WHEREAS, the memorandum of Agreement to be entered into by and between the Local Government of Sara, Iloilo and Daan sa Kaunlaran, Inc. defines the terms and conditions for the implementation of Technical Vocational Education Program in the Municipality of Sara, Iloilo;

WHEREAS, Daan sa Kaunlaran provides programs that stimulate opportunities in line with the program of the local government unit to create more jobs that allow professional growth and economic upliftment of the lives of individuals;

WHEREAS, the joint undertaking is highly beneficial to the constituents of the Municipality of Sara and includes among others: micro-, small and medium-sized enterprises (MSMEs), businessmen, professionals, academe, and civil servants;

WHEREAS, by virtue of Article II, Sec. 23 of the Philippine Constitution and Sec. 34 of Republic Act 7160, otherwise known as the Local Government Code, the partnership of Government Organizations (GO) and Non-Government Organizations (NGO) and/or People's Organization (PO) has been institutionalized;

WHEREAS, Section 444 of R.A. 7160, otherwise known as the Local Government Code of 1991, provides that Local Chief Executives shall represent the municipality in all its business transactions and sign in its behalf all bonds, contracts, and obligations, and such other documents upon authority of the Sangguniang Bayan or pursuant to law or ordinances.

NOW THEREFORE, on motion of HON. JOSEPH N. AYING SB member and duly seconded by HON. ISALIO JALANDONI SB member and by unanimous votes of the Sanggunian, be it:


