RESOLUTION NO. 090 S.2022

A RESOLUTION AUTHORIZING THE MUNICIPAL MAYOR JON N. AYING AND ACTING MUNICIPAL TREASURER JANET D. PEREMNE TO TRANSFER THE INCOME OF MUNICIPAL HEALTH LABORATORY FROM THE GENERAL FUND TO TRUST FUND OF THE MUNICIPALITY OF SARA, ILOILO.

WHEREAS, the Sangguniang Bayan of Sara, Iloilo is a duly constituted Legislative Body organized by law to pass, enact, and adopt ordinances, resolutions, and other legislative measures for the effective administration in relation with the affairs of the Municipality;

WHEREAS, the Municipality of Sara has existing General Fund and Trust Fund depository account with LANDBANK- Sara Branch, for funds of the local government unit;

WHEREAS, Republic Act No. 7160, also known as the Local Government Code of 1991, Section 309(b), Trust funds which shall consist of private and public monies which have officially come into the possession of the local government or of a local official as trustee, agent or administrator, or which have been received as a guaranty for the fulfillment of some obligation. A trust fund shall only be used for the specific purpose for which it was created or for which it came into the possession of the local government unit.;

WHEREAS, in Section 310 of Republic Act No. 7160, Local accountants and treasurers shall maintain separate books and depository accounts, respectively, for each fund in their custody or administration under such rules and regulations as the Commission on Audit may prescribe.

NOW THEREFORE, on motion by Hon. Dennis E. Caraele and duly seconded Hon. Isalio M. Jalandoni, the Body:

RESOLVED, as it is hereby resolved, authorizing the Municipal Mayor Jon N. Aying and Janet D. Peremne, Acting Municipal Treasurer, to transfer the income of the Municipal Health Laboratory from the General fund to Trust fund of the Municipality of Sara, Iloilo;

RESOLVED FURTHER, to furnish copies of this resolution to the Office of the Mayor, LandBank- Sara Branch, Municipal Treasurer Office, and other concerned agencies and department for information and appropriate action.
