RESOLUTION NO. 086 S.2022

A RESOLUTION AUTHORIZING THE LOCAL CHIEF EXECUTIVE TO ENTER INTO AND SIGN THE MEMORANDUM OF AGREEMENT BETWEEN THE ILOILO PROVINCIAL GOVERNMENT AND THE LOCAL GOVERNMENT UNIT OF SARA IN CONNECTION WITH THE PROPER DISPOSAL OF RESIDUAL WASTES GENERATED FROM THE OPERATION OF SARA DISTRICT HOSPITAL

WHEREAS, the Sangguniang Bayan of Sara, Iloilo is a duly constituted Legislative Body organized by law to pass, enact, and adopt ordinances, resolutions and other legislative measures, for the effective administration of the proceedings in relations with the affairs of the municipality;

WHEREAS, there is a need for the proper disposal of residual wastes or general wastes generated from the various hospital operations of the Sara District Hospital (SDH), for which the Local Government Unit (LGU) has the capacity to provide;

WHEREAS, the LGU shall only collect the segregated residual or general wastes every Tuesday and Friday or on any day or frequency appropriate to properly collect and dispose the volume of the residual/ general wastes generated by the hospital;

WHEREAS, the LGU shall collect, transport, and dispose the hospital's residual wastes or general wastes at the Municipal dumpsite;

NOW THEREFORE, on motion by Hon. Mychel M. Saber, duly seconded by Hon. Deoly P. Valenzuela, the body:


