A RESOLUTION AUTHORIZING THE MUNICIPAL MAYOR, HON. JON N. AYING AND ACTING MUNICIPAL TREASURER, MS. JANET D. PEREMNE AS “AUTHORIZER”, JUDY B. DEMETIEZ AND CAMILLE ANDRIAN B. BRETAN AS “MAKER”, TO ENROLL IN THE LANDBANK OF THE PHILIPPINES, SARA, ILOILO INSTITUTIONAL INTERNET BANKING, THE “WE ACCESS”

WHEREAS, the Sangguniang Bayan of Sara, Iloilo is a duly constituted Legislative Body organized by law to pass, enact, and adopt ordinances, resolutions and other legislative measures, for the effective administration of the proceedings in relations with the affairs of the municipality;

WHEREAS, on July 12, 2022, the Sangguniang Bayan of Sara, Iloilo has approved Resolution No. 083, Series of 2022 authorizing the Municipal Mayor, Hon. Jon N. 2. Designate/authorize personnel to acts as "maker" or "authorizer" for the company's access to LBP's weAccess banking facility; and
3. Amend/add/delete enrolled deposit account/s as source and/or destination account/s access rights to the weAccess modules, authorization rules and/or any information on the original and succeeding enrollments.


And the same is hereby confirmed and ratified;
